

# **Merging Parish procedures**

#### **Family Suite:**


- 1. Update all contribution records in Connect Now (if you have been using that to track them) up to the date of the change of status for the parish.
- 2. Print off the contribution statements
  - a. Print them to a PDF file so that you will be able to save that on a computer and have access to it
- 3. Move all members to another parish in the cluster
  - a. You may want to change the status of all the members of the parish to be merged to Inactive
  - b. Go to the receiving parish and click on "Add New Family". This box will appear:



c. Search for each Member and select the correct one to transfer



d. Move as Registered to the new parish



e. Once this process is completed, let Cindy Olson know that you no longer need your Parishsoft Connect Now Family Suite license for the parish that has now been merged to another parish. She will contact ParishSoft to end the license and at that point in time, any remaining period of the license fee will be refunded to you by ParishSoft.

#### **Connect Now Accounting:**

- 1. Enter all accounting data and run reports for the fiscal year (or shortened fiscal year)
- 2. Close the fiscal year
  - a. You may want to export a PDF of the General Ledger detail for the period of time you have been in Connect now to save on a computer for history purposes.
  - Run the Annual Diocesan reports through the Ledger Report Writer menu (even if it is a shortened fiscal year) and submit to the Diocese per normal procedures.

  - c. Export/Print a Trial Balance to use to set up the merging parish on the receiving parish's books.
