Tax and Wage Detail Reporting Home

[Adjustment](#) - Adjust previously submitted wage detail records. Upload a file of adjustments, or select and modify specific records online. NOTE: UI Staff may review adjustments and some administrative fees may be added.

[Submit Wage Detail](#) - Submit Quarterly Wage Detail Records for current or delinquent quarters by using one of four filing methods. Taxes, Assessments, Interest, and Fees will be calculated online through this process.

[View Submission History](#) - View basic information for each original and adjusted wage detail submission. The data includes the Submission Date and Time, Filing Method, Errors, Number of Records Processed, and Gross Wages Processed.

[Forecast Tax Calculator](#) - Enter anticipated Gross Wages and Full Time Equivalents, or anticipated Taxable Wages; the calculator will provide a breakdown of anticipated taxes, assessments, and fees. Use this for budgeting purposes.

[View History](#) - View previous submissions and adjustments for each individual wage record submitted. Access current tax calculations and 12th of Month data.
