The applicant must include a reflective statement of professional accomplishment and the applicant's own assessment of professional growth ..."</p> <p><b>Exemptions:</b></p> <ul style="list-style-type: none"> <li>• Teachers who have not taught for any portion of the five-year renewal period immediately preceding license renewal.</li> <li>• School administrators.</li> <li>• Related services personnel (school social workers, psychologists, counselors, nurses ).</li> </ul> <p><b>Required:</b></p> <ul style="list-style-type: none"> <li>• Full-time teachers.
